An Ordinance Authorizing an election on the question of increasing the bonded indebtedness of the Borough of Millville by a net amount not exceeding \$8,000.00 - Eight Thousand Dollars - being 4½ (plus) per cent. of the assessed valuation of the taxable property therein, for the purpose of creating a fund out of which the said Borough of Millville may pay its proportionate share of the costs of grading and paving State Street from the southerly line of said Borough to the northerly line thereof, and Main Street from the westerly line of the said Borough to the easterly line thereof and giving notice of such election, and

WHEREAS, the Corporate authorities of the said Borough of Millville by Ordinance duly passed and enacted into law and published by posting and advertising according to law, have signified and expressed their desire to increase the bonded indebtedness of said Borough of Millville by the amount of \$8,000.00 for the purpose of creating a fund out of which the Borough of Millville may pay its proportionate share of the costs of grading and paving Main and State Street in the Borough of Millville and for the purpose of refunding any certificates of indebtedness of said Borough of Millville as may be now outstanding, upon such terms and conditions as may be agreed upon by said Borough and the holders of said certificates of indebtedness.

THEREFORE, Be it enacted and ordained by the Burgess and Town Council of the Borough of Millville and it is hereby enacted and ordained by authority of the same.

SECTION 1. That a public election be and the same is hereby authorized and proclaimed to be held on the 2nd day of November A. D. 1915 between the hours of 7.00 A.M. and 7.00 P.M. by the legally constituted officers at the usual place of holding the Borough elections and the place of holding the regular municipal elections of the said Borough for the purpose of obtaining the assent of the electors of said Borough of Millville to an increase of said Borough of Millville to an increase in the bonded indebtedness of said Borough of Millville by the amount of \$8,000.00 or 4½ (plus) percent of the assessed valuation of the taxable property of said Borough for the purpose of creating a fund out of which the said Borough may pay its proportionate share of the costs of grading and paving Main and State Street as aforesaid, together with such expenses as are necessary and incident to the paving thereof and in order to get the information required by law. The following election statement and notice is declared.

ELECTION NOTICE.

INCREASE OF INDEBTEDNESS. Notice is hereby given to all electors of the Borough of Millville, County of Columbia, State of Pennsylvania.

In pursuance and by authority of an ordinance duly enacted and approved by the proper authorities, a public election will be held on the 2nd day of November, A. D., 1915 between the hours of 7.00 A.M. and 7.00 P.M. at the usual voting place for holding municipal elections in the said Borough of Millville, for the purpose of obtaining the vote of the qualified electors of said Borough of Millville to an increase in the bonded indebtedness of said Borough, the proper authorities of said Borough having signified and expressed their desire for such increase of indebtedness.

The amount of the last assessed valuation of the taxable property in the said Borough of Millville is \$175,105.00. The total amount of the present actual debt of said Borough of Millville is \$1,350.00.

The amount of the proposed increase of indebtedness of said Borough is \$8,000.00.

The percentage of the proposed increase of indebtedness in said Borough computed upon the last assessed valuation is 4½ (plus) percent.

The proposed increase of indebtedness of said Borough is for the following purpose:

To create a fund out of which to pay the Borough's proportionate share of the costs of grading and paving State Street in said Borough from the southerly line of said Borough to the northerly line thereof, and Main Street in said Borough from the westerly line of the said Borough to the easterly line thereof, together with such expenses as are necessary and incident to the paving thereof and for the further purpose of refunding any certificates of the said Borough, if there be any surplus of such funds, upon such terms as may be agreed upon by the holders of such certificates of indebtedness and the Borough authorities.
